MEMORANDUM OF UNDERSTANDING

ACADEMIC, TRAINING ACTIVITIES AND RESEARCH COLLABORATION

Between

Department of Computer Science Yashavantrao Chavan Institute of Science, Satara.

Department of Computer Science and Engineering Dnyanshree Institute of Engineering and Technology Sajjangad Road , Satara

Yashavantrao Chavan Institute of Science, Satara and Dnyanshree Institute of Engineering and Technology Sajjangad Road, Satara have agreed to the following protocols governing their collaboration on academic and research related activities.

Scope:

The scope of collaboration on academic and research activities in this memorandum of understanding

- Academic and Training Activities in areas of mutual interest.
- Research collaboration in areas of mutual interest.
- Exchange of academic information and scholarly information, Laboratory facilities and publications, software's and library facilities.
- Exchange of students and faculty.
- Training to students and faculty. E.g. Hardware and Software, Animation, New Programming Skills and software development, Computer Networking, Android apps, MATLAB Programming, LabView Programming, VLSI Technology, Web Designing, Different Programming Skills and any other advanced technology regarding to Computer Science and Engineering.
- Cooperative activities for faculties and students, projects, seminars, workshops and academic

Students exchange:

Persuant to the agreement for academic exchange, Department of Electronics, Yashavantrao Chavan Institute of Science, Satara and Dnyanshree Institute of Engineering and Technology, Sajjangad Road, Satara shall exchange students according to terms laid out in Annexure 1. It is desired by both parties that there will be significant flow of students in both directions.

Project work and Research collaboration:

Faculty from both institutions will collaborate in the supervision of student's exchange, student project work and in joint research as well as in disciplines of mutual interest. All such joint activities will be governed by the terms laid out in Annexure 2.

Commencement, renewal, termination and amendment:

This MOU will come into force upon affixing of the signatures of the representatives of the partner institutions and will remain in effect for 3 years. This MOU may be renewed upon its expiry, with the agreement of both partner institutions.

If either partner institution wishes to terminate the MOU at the end of 3 years period it must notify the other institution not less than 1 month prior to the expiry of MOU.

Annexure I

- The students entering from Yashavantrao Chavan Institute of Science, Satar under students exchange program will be considered as special exchange students. The special exchange students will be permitted to participate in project work, research activities, laboratory and library facilities.
- In any case the consent of the teacher /supervisor/ research supervisor is required, such consent will take into account among other things whether the student has pre requisite for the course or project.
- Neither institute will require admission or tuition fees for exchange of students under this MOU.
- Course, credits and grades earned will be determined by sending institution based on the grade report from the host institution.
- Each institution shall accept up to 25 students each year.
- Participants may not spend more than one year normally in exchange programme.
- The selection and nominations of the students is open throughout the academic year. The students nominations should be accompanied by:
 - a. Curriculum vitae
 - b. Statement of the aptitude from student's supervisor, project guide and research guide.
 - c. A specific outline or program of study of host institution and statement of objectives of the student.

- when a nomination is forwarded by the institution, it is presumed that the sending institution considered the student suitable for proposed program and consent to send the student if selected by the host institution.
- The host institution will evaluate the nomination and determine their suitability for selection under the students exchange program.
- as a part of B.Sc(Computer Science), B.C.S., M.Sc., B.E., M.E., B.Tech., M. Tech. M.Phil., Ph.D. degree programme., the host institution will provide a suitable faculty member to jointly assist the exchange student in formulating research project, curriculum project or jointly supervising project for the exchange students in the event that the suggested projects have been already identified.
 - The host institution will inform the home institution of any academic or other problems that may arise during the period of students residence in the host institution.
 - The host institution will take appropriate action under its established policy and procedures in consultation with the home institution to deal with such problems.

Annexure II

- The proposals for collaborative research work under this memorandum will be submitted with the prior approval of the Head of the Department and Head of Institution.
- Each institution will nominate one of its members as its representative incharge of the cooperative program. Individual programs of work under this memorandum will be jointly planned and conducted by the nominees of both parties.
- The final approval of any project will depend on the availability of guaranteed support funds.
- The resources and facilities of Laboratory test and measuring instruments, equipments, related software's will be made available to requesting institute.
- Each institute should voluntarily assist the exchange of laboratory equipments, related software's and required facilities and maintain the records.
- The requesting institute shall maintain records regarding the aid requested and received under this MOU.
- Any other academic, training and research activities agreed by both institutes.

This agreement or its renewal and the actions taken under it may be reviewed at any time. These modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between two parties.

 - Progress of work of any individual programme will depend on the availability and guaranteed support funds.

Commencement, Renewal, Termination and Amendment:

This MOU will come into force upon affixing of the signature of the representatives of the partner institutions and will remain in effect for three years. This MoU may be renewed up on its expiry with the agreement of both partner institutions.

If either partner institute wishes to terminate the MoU at the end of five years period it must notify the other institution not less than six months prior to the expiry of the MoU.

This agreement or its renewal and the actions taken under it may be reviewed at any time. Modification may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two parties.
